## AGENDA MEETING

CALL TO ORDER: Mayor Anesh called the meeting to order at 7:00 p.m. Mayor Anesh read the sunshine statement and announced that same is being held pursuant to the Open Public Meetings Act of 1974 and all provisions of that Act have been met with adequate notice of this remote hybrid meeting having been provided to the Borough's two official newspapers and also published on the Borough's website. Review of Agenda Items: Clerk Antonides reviewed all the items on the agenda adding \$4,970.46 plus \$1,779.00 in wires to the bills list for a new grand total bills list of \$939,129.18. Mr. Cullen pointed out that Ordinance 2319 is for the new fuel station of which is primarily funded with state grant funding and resolution 24-253 is for a new shed for the recycling center that will be primarily funded by a 2024 municipal recycling enhancement grant.
